Proposed amendments to the constitution

- A) Under section 4 (Membership):-Delete :- (except under 18 student members)
4.1 should read as "There will only be one category of membership (ie Life Membership)".
Delete 4.1 (a).

Under section 4.2 (Termination of membership)
Delete 4.2 (a).

Section 4.3 should read as "A membership register must be maintained by electronic means as well as hard copy".
"Communication with members must be carried out at least once a year by post or by other suitable means".

- B) Under 5 Delete 5C Delete a.(Only 5b is left so there will only be 5)

- C) delete 6.3 and add the following:-

All members of the Management Committee are expected to devote substantial amount of time for the smooth running of the society.

Under 6.4:- delete words "or political organisation"

- D) Under Clause 8

Add: 8.1 (f) The successful applicant for any post must undergo a DBS check. A failure of the DBS check will mean that the person will no longer be a post holder. The executive committee will appoint a replacement.

- E) Under the section 11 (Election of the office holders)

Clause 11.2 is to be replaced with the following

Only the members who have been a member of the previous executive committee and have been member of the Society for more than Two (2) years shall be eligible.

Amend Clause 11.4 (2) the remaining Six (6) members of the management committee shall be nominated by the elected post holders within two weeks after the election. At least , Outgoing one of the (3), being Hon Gen Sec , Assist Hon Gen Sec or the Treasurer must be included in the management committee for the continued smooth running of The Sikh missionary Society.

12-1b & 12-1c Previously agreed to be deleted by the members at the Sept;2012 AGM

F) Under Clause 13 (Qualifications of Trustees)

Addition of 13.2

All trustees must provide credible proof of Fixed Tangible assets.

A trustee who has served two consecutive terms shall not be eligible to contest for the next term.

G) Under clause 15 (Power and duties of Trustees)

In 15.5 Replace 10 yrs by 6yrs and the current year..

Under 15.5 delete words "such as property papers".

Add; Permanent documents such as "Title Deeds" must be retained indefinitely

15.5 Should read:-

The trustees will ensure with the general Secretary that important records of the Society financial statements and minutes books are safely retained for a period of at least 6 years and the current year . Permanent documents such as " Title Deeds " must be retained indefinitely.

Note:- Anywhere in the book the word written as "Punjabi" should be replaced by the word "Panjabi"
